**CALL TO ORDER**

**SOLID WASTE UPDATES, CONRAD WELCH**

Conrad Welch, Director of Solid Waste, was present with updates from his department. He stated that with it being Christmas time, they are bailing as quickly as they can. The aluminum can picker that was purchased using grant funding is nearly completed and ready for use. He also noted that bids are currently out to fix a seep at the landfill, and that cost will be approximately \$50,000. Joe inquired about current contracts that solid waste has out and how long they may have left. Joe also mentioned the desire to have some kind of solid waste study done to determine if there are things we can do better.

**ROAD LIST CHANGE (YOUNGSTOWN AVE 2)**

Stanley Hall, Road Superintendent, was present with details on this road. County attorney Burnett was also present and noted that the road was on the official road list from 1995 – 2004, and then it did not appear again from 2005 to present, but records were not kept regarding its removal. It is Stanley and Philip's opinion to add it back to the list. Stanley stated that the condition isn't great, but it isn't the worst. It will need a new cross drain. There was a motion from Jack Davis to approve the addition of Youngstown Ave 2 to the road list. John seconded the motion, none were opposed, and the motion carried.

Colleen asked if the road list could be sorted by district, and right now that isn't a possibility.

**2025 ROAD LIST APPROVAL**

There was a motion by Jack to approve the 2025 Road List. John seconded the motion, none were opposed, and the motion carried.
