September 21, 2020 Monthly Meeting Minutes

Be it remembered that the Cumberland County Commission met in monthly session on Monday, September 21, 2020 at the Cumberland County Courthouse in Crossville, Tennessee. Cumberland County Deputy Ray Seiber called the meeting to order at 6:00 o'clock P.M. Present and presiding was Mayor Allen Foster who invited Pastor Andrew Abraham of Shepard of the Hills to deliver the invocation. 4. RESOLUTION 09-2020-2 – AMEND THE CONTRACT BETWEEN THE STATE OF TENNESSEE, DEPARTMENT OF MENTAL HEALTH AND CUMBERLAND COUNTY, TENNESSEE:

Discussion: Commissioner Mall asked where the monies come from to fund this contract. Finance Director, Nathan Brock stated that it came from the jail medical and is usually with minimal uses.

5. RESOLUTION 09-2020-3 – BUDGET AMENDMENT, GENERAL FUND, COUNTY COMMISSION CAPITAL EXPENDITURES:


