APPLICATION MUST BE SUBMITTED PRIOR TO THE MEETING OF THE CUMBERLAND COUNTY COMMISSION WHICH IS HELD THE THRD MONDAY OF EACH MONTH. ONCE ELECTED, A NOTARY BOND OF TEN THOUSAND DOLLARS (\$10,000) MUST BE FILED IN THE COUNTY CLERKS OFFICE.
