

- (c) To establish a process by which employees, taxpayers, or other citizens may confidentially report suspected illegal, improper, wasteful or fraudulent activity under provisions by T.C.A. Section 9-3-406.
- (d) To annually present a written committee report detailing how it discharged its duties and any committee recommendations to the full County Commission; and

WHEREAS, there are expiring terms on the Cumberland County Audit Committee; and

RESOLUTION NO. 08-2023-5

RESOLUTION PROCLAIMING SEPTEMBER 29 AS FIRST SERGEANT MILO LEMERT DAY IN CUMBERLAND COUNTY

WHEREAS, Milo Lemert was a resident of Cumberland County, Tennessee; and

WHEREAS, on June 25, 1917, he enlisted in the Tennessee Army National Guard, and during his training was promoted to sergeant because of the leadership qualities he possessed; and

WHEREAS, in March of 1918, First Sergeant Lemert was deployed to Bellicourt, France during World War I with the Old Hickory Division; and

WHEREAS, on September 29, 1918, First Sergeant Lemert reorganized his heavily wounded unit, and singlehandedly led the company to attack the enemy with hand grenades at the Hindenburg Line, resulting in the destruction of all enemy soldiers and four machine gun emplacements; and

WHEREAS, despite his courageous actions, First Sergeant Lemert was killed by enemy fire during the attack; and

WHEREAS, the actions of First Sergeant Lemert that day saved the lives of many of his fellow soldiers, and his widow was presented with his Medal of Honor on October 19, 1919; and

WHEREAS, First Sergeant Lemert is buried at the Crossville City Cemetery in Crossville, Tennessee; and

WHEREAS, in 1991, the Cumberland County Commission renamed the Cumberland County Courthouse Annex #3 the 'Milo Lemert Memorial Building;' and

WHEREAS, American Legion Post 163 of Crossville, Tennessee has petitioned Cumberland County to proclaim September 29 of each year as First Sergeant Milo Lemert Day, in memory of First Sergeant Lemert, his heroic actions in war time, and the legacy he left behind;

NOW, THEREFORE, BE IT RESOLVED, by the Cumberland County Commission that September 29 of each year be proclaimed as 'First Sergeant Milo Lemert Day,' that the day be observed with appropriate activities, and the acknowledgment of the honor and recognition that First Sergeant Milo Lemert brings to Cumberland County.

RESOLUTION REGARDING THE COUNTY ARCHIVES, AND THE COUNTY CLERK'S OFFICE

WHEREAS, Resolution 07-2011-3 established the Cumberland County Archives and Family Heritage Center at 95 East First Street; and

WHEREAS, Resolution 08-2018-2 established records maintenance fees in accordance with State law; and

WHEREAS, Resolution 01-2021-07 approved a construction and renovation project for the County Archives facility; and

WHEREAS, Resolution 01-2021-08 approved the issuing of capital outlay notes not to exceed \$1,600,300.00 in aggregate principal, to provide funds for the future of the County Archives project; and

WHEREAS, plans were drawn and bids came in higher than anticipated due to the spike in construction costs, Resolution 06-2021-9, written to fund the project with an additional \$280,125 using the designated fees established in Resolution 08-2018-2, failed with nine votes for and eight votes against, with one absent; and

WHEREAS, Resolution 08-2021-6 redirected funds borrowed in Resolution 01-2021-08 and approved the purchase of the former Progressive Savings Bank located at 1760 S Main Street Crossville, TN – Cumberland County Map 113 Parcel 022.01 for \$1.125 million dollars with revenue from archives fees being used to pay for the purchase and renovation for the County Archives facility; and

WHEREAS, Resolution 11-2022-2 temporarily halted construction at 1760 S Main Street until January 31, 2023, while a permanent solution was found and funded for the locations of both the County Clerk's office and the Cumberland County Archives; and

WHEREAS, the Building and Grounds Committee convened on December 13, 2022 with much discussion concerning the location and renovations for the County Clerk's office and the County Archives facility, as well as discussion on renovations needed at the 1905 Cumberland County Courthouse; and

WHEREAS, Resolution 01-2023-4 authorized:

- A. The original amount of \$1,600,300 via Resolution 01-2021-08, plus the additional amount required to cover architect fees not to exceed \$65,000, to be allocated to tear down the rear portion of the current County Archives facility, and rebuild using a smaller footprint of two floors of approximately 2,000 square feet each, with work being completed by a professional contractor.
- B. The County Clerk's office to remain at 1760 S Main Street, with \$10,000 allocated from funds as determined by the Budget Committee, to reinstall the drive through window, a

- canopy, and other work needed to restore the building, with the work to be completed by TCAT.
- C. Reimburse the \$1.125 million allocated via capital outlay note in Resolution 01-2021-08 used for purchasing 1760 S Main Street, plus any other expenses taken from the original \$1,600,300 allocated to the archives project, using funds from Debt Service Fund Balance or General Fund Fund Balance, as determined by the Debt Management Committee.
- D. No construction or renovation work will proceed at 1760 S Main Street until plans for the County Archives project are approved and funded by the full Cumberland County Commission.

WHEREAS, the Building & Grounds Committee, meeting on July 6, 2023, gave permission to the Architect to move forward without coming back to the committee for additional votes; and

WHEREAS, plans were redrawn in an attempt to meet the requirements of Resolution 01-2023-4, and on July 27, 2023, bids came in higher than the funds allocated with a low bid of \$2,095,138;

NOW, THEREFORE, BE IT RESOLVED, that the Cumberland County Commission hereby expressly authorizes:

- A. The demolition and rebuild project for the County Archives facility whereby the rear portion of the current County Archives facility shall be torn down and replaced with a smaller footprint of two floors totaling approximately 2000 square feet each is hereby approved.
- B. The Cumberland County Mayor to execute any formal agreements and related documents for the completion of this project.
- C. That without further approval by this body, the project cost, including architect fees, shall not exceed \$2,160,138.00, with said budget amendments being approved as set out below.
- D. That construction and renovation work may proceed at 1760 S Main Street.
- E. That the following budget amendment be adopted by the Cumberland County Commission:

ITEM 1: CALL TO ORDER

Upon determining a quorum was present, Vice-Chairman Wendall Wilson called the regular meeting of the Cumberland County Regional Planning Commission (PC) to order at 5:00 P.M. on June 15, 2023 at the Cumberland County Courthouse.

ITEM 2: APPROVAL OF MAY 18, 2023 MINUTES

After calling the meeting to order, Vice-Chairman Wilson asked for approval of the May 18, 2023 minutes. Kelli Tipton made a motion to dispense with the reading of the minutes and approve the minutes as presented. Katie Hardt seconded and the motion passed with a vote of all ayes.

ITEM 3: CONSIDERATION OF FINAL SUBDIVISION PLAT FOR PROPERTY LOCATED ON PRICE LOOP AND WALTON COURT (EDDINGTON DIVISION)

Surveyor Randall Hamilton presented a final subdivision plat on behalf of Kenneth Eddington for the purpose of subdividing 7.74 acres into three (3) proposed new lots located on Price Loop and Walton Court. Lot 1 would consist of 1.04 acres, an existing residential structure and two (2) existing accessory structures. Lot 2 would consist of 1.79 acres and an existing residential structure. Lot 3 would consist of 4.91 acres and is currently vacant. The proposed new lots would be served by an existing four (4) inch water line and would comply with all Cumberland County Subdivision Regulations. After discussion, Kelli Tipton made a motion to approve the submitted final subdivision plat pending that all required signatures be obtained. Katie Hardt seconded and the motion passed with a vote of all ayes.

ITEM 4: CONSIDERATION OF FINAL SUBDIVISION PLAT FOR PROPERTY LOCATED ON BROWNTOWN ROAD (BLAYLOCK DIVISION)

Surveyor Rusty Norrod presented a final subdivision plat on behalf of Gary Blaylock for the purpose of subdividing 3.03 acres into three (3) proposed new lots located on Browntown Road. Lot 1 would consist of 1.01 acres and is currently vacant. Lot 2 would consist of 0.74 acres, an existing residential structure and an existing accessory structure. Lot 3 would consist of 1.28 acres, an existing residential structure and three (3) existing accessory structures. The proposed new lots would be served by an existing four (4) inch water line and would comply with all Cumberland County Subdivision Regulations. After discussion, David Gibson made a motion to approve the submitted final subdivision plat pending that all required signatures be obtained. John Stubbs seconded and the motion passed with a vote of all ayes.

ITEM 5: STAFF REPORT

Staff Planner presented a report for five (5) subdivision plats that had been administratively approved since the last planning commission meeting. The administratively approved subdivision plats are as follows:

McCarthy Division—Final

Katherine McCarthy submitted a final subdivision plat for the purpose of creating one (1) proposed new lot from property larger than five (5) acres located on Plateau Road. The proposed new lot would consist of 1.75 acres and an existing structure. The proposed new lot would be served by an existing six (6) inch water line and would comply with all Cumberland County Subdivision Regulations

Olsen Division—Final

Kathy Olsen submitted a final subdivision plat for the purpose of subdividing 2.60 acres into two (2) proposed new lots located on Bell Road. Lot 1 would consist of 0.70 acres, an existing residential structure and three (3) existing residential structures. Lot 2 would consist of 1.90 acres and an existing residential structure. The proposed new lots would be served by an existing four (4) inch water line and would comply with all Cumberland County Subdivision Regulations.

Selby Division—Final

Steven Selby submitted a final subdivision plat for the purpose of creating one (1) proposed new lot from property larger than five (5) acres located on Old State Highway 1 and Red Road. The proposed new lot would consist of 2.500 acres and is currently vacant. The proposed new lot would be served by an existing four (4) inch water line and would comply with all Cumberland County Subdivision Regulations.

Glenn Combination -Final

Keith Glenn submitted a final combination plat for the purpose of creating one (1) proposed new lot from two (2) existing lots located on Robin Hood Court. The proposed new lot would consist of 0.688 acres and is currently vacant. The proposed new lot is served by an existing six (6) inch water line and would comply with all Cumberland County Subdivision Regulations.

Hale Combination--Final

John Hale submitted a final combination plat for the purpose of creating one (1) proposed new lot from three (3) existing lots located on Cherokee Road East. The proposed new lot would consist of 1.25 acres and an existing residential structure. The proposed new lot is served by an existing six (6) inch water line and would comply with all Cumberland County Subdivision Regulations.

Vowell Adjustment-Final

Jimmy Vowell submitted a final lot line adjustment plat for the purpose of adjusting the common boundary line of two (2) existing lots located on Carrie Drive. After the adjustment, Lot 1 would consist of 4.54 acres, an existing residential structure and an existing accessory structure. Lot 2 is larger than five (5) acres and is not subject to the jurisdiction of the PC. The proposed new lot would be served by an existing six (6) inch water line and would comply with all Cumberland County Subdivision Regulations.

ITEM 6: DISCUSSION REGARDING CHANGING THE NAME OF KILBY FARM ROAD TO DAUGHERTY LANE

Staff Planner presented a request on behalf of Lee Daugherty to change the name of Kilby Farm Road to Daugherty Lane. Staff Planner stated that according to Daugherty, he was the only address located on Kilby Farm Road. Staff stated that while Daugherty may be the only address on Kilby Farm Road, there was another affected property owner that had frontage on Kilby Farm Road. After discussion, Vice-Chairman Wilson

requested that Staff schedule a public hearing for the July 20, 2023 PC meeting. Staff Planner stated that he would schedule the meeting and also contact the other affected property owner by mail.

ITEM 7: DISCUSSION REGARDING THE SURETY INSTRUMENT ACCEPTANCE

At the December 15, 2022 meeting Staff Planner provided training on Surety Instruments. During the training, there was discussion about the strength of letters of credit. Staff Planner stated that the process for accepting surety instruments should be reviewed. Attorney Philip Burnett stated that he would research the reliability of a letter of credit. At the January 19, 2023 meeting, Attorney Burnett stated that outside of the expiration date, a letter of credit should be an acceptable surety instrument. Member John Stubbs stated the PC should research the effectiveness of a performance bond as an alternative to a letter of credit. After discussion, Chairman Smith requested that the staff planner schedule a public hearing for the March 16, 2023 PC meeting to discuss amending the subdivision regulations for alternative acceptable surety instruments. At the March 16, 2023 meeting, Chairman Smith closed the PC meeting and opened a public hearing to receive comments regarding acceptable surety instruments. There was no public comment and thus Chairman Smith closed the public hearing and reopened the PC meeting. Chairman Smith then reopened the floor for discussion regarding acceptable surety instruments. Secretary Kyle Davis stated that he had concerns on performance bonds being cost prohibitive to developers while Member Wendall Wilson had no issues with performance bonds. After discussion, it was determined that staff planner should present a draft amendment to include performance bonds. Also, Chairman Smith asked Stubbs to present bond rates at the April 20, 2023 meeting. Due to the fact that Stubbs was absent, Chairman Smith tabled the meeting. At the May 18, 2023 meeting, Stubbs stated that a performance bond would cost a developer approximately \$1,000 per \$100,000 of estimated construction. After discussion, it was the consensus of the PC that an example of performance bond language from another county should be presented at the next PC meeting. Vice-Chairman Wilson tabled discussion. At the June 15, 2023 meeting, Staff Plannerpresented a sample of a performance bond to the PC for review that had been submitted by Stubbs. After review, it was the consensus of the PC to have Attorney Burnett review the bond template and also that the bond template should not have an expiration date. Vice-Chairman Wilson tabled discussion.

With no other business, John Stubbs made a motion was made by to adjourn. David Gibson seconded and the motion passed with a vote of all ayes. The next scheduled meeting of the Cumberland County Planning Commission is scheduled for July 20, 2023.

Dear Mr. Lee:

With this letter we the residents/property owners on Parnell Road request Cumberland County to extend Parnell Road .037 miles to 0.93 mile.

One of the undersigned was advised by a neighbor on July 6, 2023, that a major section of Parnell Road was "declared private after the flood in 1940," with only 0.37 mile remaining under control of the Cumberland County Road Department. To our surprise, this 0.37 mile is reflected as such only in the Highway Department Documents – Cumberland County 2023 County Road List.

For example, one of families purchased their property on September 15, 2000. Their Warranty Deed and Survey does not indicate that the portion of Parnell Road where they reside is private (residents responsible for maintenance). Had this been shared prior to closing, they would not have purchased the land.

All three of the affected resident properties and their corresponding Warranty Deeds and Surveys indicate that indicate that Parnell Road extends all the way to the beginning of the properties entrance boundaries. (Approximately 0.93 miles from Clint Lowe Road), with "Parnell Road 40 Foot WO."

Over the years, the Cumberland County Road Department has maintained Parnell (tar and chip, filled potholes, and replaced culvert). Yet to date, no official has advised any of us that we reside on a private road.

Looking forward to a positive change on this record request.
