

LEASE AND AGREED REVOCATION OF PRIOR LEASE

THIS AGREEMENT, made and entered into on this theday of, 2024, by and between CUMBERLAND COUNTY, TENNESSEE, a political subdivision of the State of Tennessee, hereinafter referred to as LESSOR; and the MILITARY MEMORIAL MUSEUM OF UPPER CUMBERLAND, INC., hereinafter referred to as LESSEE.
WITNESSETH: That the Lessor hereby leases, rents, and demises to the Lessee the following described premises:
In the First Civil District of Cumberland County, Tennessee, bounded and described as follows:
Being the octogen building made predominately of crab orchard stone being approximately square feet and sitting in the farthest Southwest Corner of the Cumberland County Courthouse property.
The Lessor and Lessee covenant with one another to comply with and observe each and every one of the following conditions, covenants, and restrictions:

TERM:

the claimed breach, (unless the breach is cured by Lessee, within the period of the 10 days' notice), at their option declare the lease forfeited and expel said Lessee therefrom without prejudice to other remedies; however, notice to quit possession and every other formality is hereby expressly waived in case of such default.

UTILITIES:

5. Lessor agrees to pay for water, electric, and gas utilities if available.

LIABILITY:

- 6. A) <u>Liability to Lessee and Third Parties</u>—Lessee covenants that the Lessor shall not be liable for any damage to or injury of the Lessee or other tenants, the Lessee's agents or employees, or to any person entering the premises or building of which the demised premises are a part, or to the goods or chattels therein, and further, to indemnify and save the Lessor harmless from all claims of every kind and nature growing out of said matters.
 - B) <u>Liability Insurance</u> The Lessee, pursuant to the conditions above, shall purchase insurance with minimum limits of one million (\$1,000,000.00) dollars per occurrence and two million (\$2,000,000.00) dollars aggregate to cover not only the Lessee, but also the Lessor for all perils, including but not limited to personal injury, fire, theft, and any and all perils; with the Lessor being covered either by endorsement or as a loss payee on the policy, as the case may be.

HOLDING OVER:

7. Lessor agrees that any holding over by Lessee after the expiration of this or any subsequent lease acquired as a result of the options to renew above granted, if any, shall not constitute an automatic renewal of this or any subsequent lease. However, Lessee will be responsible for the payment of rent during the period of any such holding over.

MAINTENANCE; CONDITION OF REALTY:

- 8. A) Condition of Realty Lessee has inspected the demised premises and hereby agrees to maintain said building, and to keep all equipment as well as all buildings and structures in good working condition, normal wear and tear excepted. Lessee accepts said premises in their present condition "AS IS" and agrees to keep the premises in a good and clean condition. Lessee promises to obey all laws, ordinances, and lawful regulations affecting said premises.
 - B) <u>Maintenance</u> Unless there is damage caused to the premises by the negligence or neglect of the Lessee, the Lessor, as a condition of this lease, hereby covenants that it will pay for all repairs to the premises during the duration of the lease.
 - C) <u>Adherence to Museum Codes</u> Lessee will become accredited with and will adhere to the Standard of Museum practices as outlined by the Tennessee Association of Museums.

- D) <u>Yearly Audit</u> Lessee will provide to the Lessor a yearly Audit of financial operations. If the Lessee fails to provide this audit or if the audit shows financial distress or insolvency, the Lessor shall have the option to terminate this Lease.
- E) <u>Contact</u> Lessor requires that the County Mayor or its designee be the contact for all operations undertaken by the Lessee within the confines of the demised premises and will report quarterly to the County Mayor.

9. Should the premises described by this lease be destroyed for any reason, then and in that event the Lessor shall in its own discretion decide whether to re-build the building using the insurance proceeds or to accept the proceeds as full and final settlement of this Lease.



WHEREAS, in order to fund the 2008 Loan Agreement, the Authority issued its Local Government Public Improvement Bonds, Series VII-B-2 (the "Series VII-B-2 Bonds") pursuant to an Indenture of Trust, dated as of August 1, 2008, as supplemented by the Series VII-B-2 Supplemental Indenture of Trust, dated as of November 1, 2008 (the "Original Series VII Indenture") each between the Authority and Regions Bank, an Alabama banking corporation, Nashville, Tennessee, as trustee (the "Trustee"); and

WHEREAS, the Series VII-B-2 Bonds were purchased by U.S. Bank National Association on December 29, 2010 in connection with the remarketing of the Series VII-B-2 Bonds to establish a Bank Rate Period, and in connection with such remarketing the County and the Authority entered into an Amended Restated Loan Agreement dated December 1, 2010 (the "Series VII-B-2 Loan Agreement"), which amended and restated the 2008 Loan Agreement, and the Authority and the Trustee subsequently entered into the Series VII-B-2 Second Supplemental Indenture of Trust, dated as of December 1, 2010, the Series VII-B-2 Third Supplemental Indenture of Trust, dated as of December 1, 2013, the Series VII-B-2 Fourth Supplemental Indenture of Trust, dated as of December 30, 2016, the Series VII-B-2 Fifth Supplemental Indenture of Trust, dated as of August

1, 2018; and the Series VII-B-2 Sixth Supplemental Indenture of Trust, dated as of July 30, 2021 (the Original Series VII Indenture as supplemented is herein referred to as the "Indenture"), each between the Authority the Trustee; and

WHEREAS, it is hereby determined by the Board of County Commissioners (the "Governing Body") to be in the best interest of the County to (i) convert the interest rate on the VII-B-2 Bonds from the Bank Rate to a Daily Rate (as defined in the Indenture); (ii) enter into an Amended and Restated Loan Agreement, amending and restating the Series VII-B-2 Loan Agreement in substantially the form of the 2008 Loan Agreement, and approve a Series VII-B-2 Seventh Supplemental Indenture in connection with such conversion, (iii) approve Truist Bank as the letter of credit provider ("Credit Provider") for the Series VII-B-2 Bonds pursuant to a Reimbursement Agreement in accordance with the Truist Term Sheet before the Governing Body at this meeting (the "Credit Provider Term Sheet"), (iv) approve the remarketing of the Series VII-B-2 in the Daily Rate by Truist Securities ("Remarketing Agent") pursuant to the ("Remarketing Term Sheet"), and (v) pay costs incident to the foregoing; and

WHEREAS, for the purposes recited above, the Governing Body of the County adopts this Resolution.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Cumberland County, Tennessee, as follows:

Section 1. <u>Approval of Conversion</u>.

The Series VII-B-2 Bonds, which funded the Series VII-B-2 Loan Agreement currently bear interest at the Bank Rate as defined in the Indenture. The Governing Body hereby authorizes the County Mayor, in consultation with the Finance Director, to elect to direct a conversion of the interest rates on the Series VII-B-2 Bonds, and thus the Series VII-B-2 Loan Agreement, from the

Bank Rate to the Daily Rate (as such term is defined in the Indenture). The County Mayor and the County Clerk are hereby authorized to give notice to the Trustee of the County's direction that the interest rate on the Series VII-B-2 Bonds be converted from the Bank Rate to the Daily Rate in accordance with provisions hereof.

Section 2. Approval of Remarketing.

The conversion to the Daily Rate shall occur through a remarketing of the Series VII-B-2 Bonds by the Remarketing Agent. The Governing Body hereby approves the Remarketing Agent as the remarketing agent with respect to the remarketing of the Series VII-B-2 Bonds in the Daily Rate Period and as the remarketing agent while the Series VII-B-2 Bonds remain in the Daily Rate Period or the Weekly Rate Period. The County Mayor and County Clerk are hereby authorized, empowered and directed to execute and deliver such documents in connection with the remarketing of the Series VII-B-2 Bonds in the Daily Rate Period consistent with the Remarketing Term Sheet. From and after the execution and delivery of such remarketing documents, the County Mayor and the County Clerk are hereby authorized, empowered and directed to do all such acts and things and to execute all such documents as may be necessary to carry out and comply with the provisions thereof.

Section 3. Approval of Disclosure Document.

The County Mayor or the Finance Director, or either of them, working with the Remarketing Agent, is hereby authorized and directed to provide for the preparation and distribution of a disclosure document (the "Disclosure Document") in connection with the remarketing of the Series VII-B-2 Bonds describing the Series VII-B-2 Bonds. The County Mayor shall make such completions, omissions, insertions and changes in the Disclosure Document not inconsistent with this resolution as are necessary or desirable to complete it as a final Disclosure

Document for purposes of Rule 15c2-12 of the Securities and Exchange Commission, if applicable. The County Mayor or the Finance Director, or either of them, are authorized, on behalf of the County, to deem the Preliminary Disclosure Document and the Disclosure Document in final form, each to be final as of its date within the meaning of Rule 15c2-12(b)(1), if applicable, except for the omission in the Preliminary Disclosure Document of certain pricing and other information allowed to be omitted pursuant to such Rule 15c2-12(b)(1). The distribution of the Preliminary Disclosure Document and the Disclosure Document in final form shall be conclusive evidence that each has been deemed in final form as of its date by the County except for the omission in the Preliminary Disclosure Document of such pricing and other information.

Agreement; Pledge of Taxes. In connection with the conversion to the Daily Rate, the Series VII-B-2 Loan Agreement will be amended and restated by the Amended and Restated Series VII-B-2 Loan Agreement, to be in substantially the form of the 2008 Loan Agreement, which and is hereby approved with such changes therein as shall be approved by the County Mayor and County Clerk, the execution thereof by the County Mayor and the County Clerk to constitute conclusive evidence of the approval of any and all changes or revisions therein. The County Mayor and County Clerk are hereby authorized, empowered and directed to execute and deliver the Amended and Restated Series VII-B-2 Loan Agreement in the name and on behalf of the County. From and after the execution and delivery of the Amended and Restated Series VII-B-2 Loan Agreement, the County Mayor and the County Clerk are hereby authorized, empowered and directed to do all such acts and things and to execute all such documents as may be necessary to carry out and comply with the provisions of the Amended and Restated Series VII-B-2 Loan Agreement as executed.

The County, through the Governing Body, hereby reaffirms, covenants and agrees to annually levy and collect a tax upon all taxable property within the County, in addition to all other taxes authorized by law, sufficient to pay when due the annual amounts payable by the County under the Amended and Restated Series VII-B-2 Loan Agreement as and when they become due and payable and to pay any expenses of maintaining and operating the Projects required to be paid by the County under the terms of the Amended and Restated Series VII-B-2 Loan Agreement and. for such purposes, the County hereby pledges such tax and the full faith and credit of the County to such payments, provided, however, that the tax hereinabove described will not be required to be levied or, if levied, may be proportionately reduced to the extent of funds appropriated by the Governing Body of the County to the payment of the amounts described above from other revenues of the County. Such tax, to the extent levied, shall be assessed, levied, collected and paid in like manner as other taxes of the County. Such tax shall not be included within any statutory or other limitation of rate or amount for the County but shall be excluded therefrom and be in addition thereto and in excess thereof, notwithstanding and without regard to the prohibitions, restrictions or requirements of any other law, whether public or private. Any amounts payable under the Loan Agreement falling due at any time when there are insufficient funds from the tax levy on hand shall be paid from current funds of the County and reimbursement therefor should be made out of the taxes hereby provided to be levied when the same shall have been collected.

Section 5. Approval of Reimbursement Agreement.

The conversion of the Series VII-B-2 Bonds to a Daily Rate shall be effective only upon receipt of a letter of credit in accordance with the provisions of the Indenture. The Governing Body hereby approves the Credit Provider as the letter of credit provider pursuant to a Reimbursement Agreement which shall be substantially consistent with the terms of the Credit

Provider Term Sheet before this meeting. In the event the Series VII-B-2 Bonds cannot be remarketed on any Tender Date or the Reimbursement Agreement terminates, the Credit Provider will pay the principal and interest next coming due on the Series VII-B-2 Bonds and will be reimbursed for such payment pursuant to the Reimbursement Agreement from funds to be paid by the County. Under certain circumstances, as described in the Amended and Restated Series VII-B-2 Loan Agreement, all obligations under the Amended and Restated Series VII-B-2 Loan Agreement, including the outstanding principal amount thereof and fees and expenses of the Credi Provider, may become immediately due and payable or be subject to an adjusted amortization at an increased rate of interest, all substantially in accordance with the Credit Provider Term Sheet. The Governing Body is aware of the risks and benefits associated with the proposed transaction and is aware that should the Amended and Restated Series VII-B-2 Loan Agreement become due and payable or be subject to an adjusted amortization, as described in the Credit Provider Term Sheet, that it may be necessary or advisable to refinance the Amended and Restated Series VII-B-2 Loan Agreement, and the County understands that it may incur additional costs in connection with such refinancing and may be required to submit a plan of refunding to the State Comptroller in connection with any such refinancing.

The County Mayor and County Clerk are hereby authorized, empowered and directed to execute and deliver such documents in connection with the Reimbursement Agreement and the letter of credit consistent with the Credit Provider Term Sheet. From and after the execution and delivery of such documents, the County Mayor and the County Clerk are hereby authorized, empowered and directed to do all such acts and things and to execute all such documents as may be necessary to carry out and comply with the provisions thereof.

Section 6. Amendment to the Series VII-B-2 Supplemental Indenture. The Governing Body hereby directs the County Mayor to request that the Authority, the Trustee and any other required parties approve and consent to amendments to the Series VII-B-2 Indenture, the Series VII-B-2 Loan Agreement and such other documents necessary to effect the amendments to provide for the conversion of the Series VII-B-2 Bonds to the Daily Rate Period, all of which shall contain terms and provisions consistent with the Credit Provider Term Sheet and the Remarketing Term Sheet now before this meeting.

Section 7. Interest Rate Conversion. At any time while the Series VII-B-2 Bonds remain outstanding, the Amended and Restated Series VII-B-2 Loan Agreement and the Series VII-B-2 Bonds, may, in whole or in part, to the extent permitted by applicable law, be converted from one Rate Period (as defined in the Loan Agreement) to the other interest Rate Periods permitted and as provided in the Amended and Restated Series VII-B-2 Loan Agreement and in the Indenture (which conversion may include such put features relative to the Series VII-B-2 Bonds as the Indenture may permit) at the direction of the County Mayor and County Clerk and no further action shall be required by the Governing Body.

Section 8. <u>Additional Authorizations</u>. All acts and doings of the County Mayor and the County Clerk and any other representative or officer of the County which are in conformity with the purposes and intent of this Resolution shall be and the same hereby are in all respects, approved and confirmed.

Section 9. <u>Separability</u>. If any section, paragraph or provision of this Resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this Resolution.

Section 10. <u>Repeal of Conflicting Resolutions and Effective Date</u>. All other resolutions and orders, or parts thereof, in conflict with the provisions of this Resolution, are, to the extent of such conflict, hereby repealed and this Resolution shall be in immediate effect from and after its adoption.

Legal Description for the Annexation of Tax Map 112L C 014.00 with a portion of Canary Drive

BEGINNING on a point, said point being a common property corner of Tax Map 112E G 018.00 and 112E G 017.00, located on the north eastern ROW of Canary Drive.

Thence in a south eastern direction, following the north eastern ROW of Canary Drive to a point, said point being a common property corner of Tax Map 112L C 015.00 and 112L C 014.00.

Thence in a north eastern direction following a common property line of Tax Map 112L C 015.00 and 112L C 014.00 to a point, said point being a common property corner of Tax Map 112L C 014.00 and 112L C 013.00.

Thence in a south eastern direction, following a common property line of Tax Map 112L C 014.00 and 112L C 013.00 to a point, said point being a common property corner of Tax Map 112L C 014.00 and 112L C 013.00, located on the north western ROW of Walnut Drive.

Thence in a south western direction, following the northern ROW of Walnut Drive and crossing Canary Drive to a point, said point being on the western ROW of Canary Drive.

POLICE.

Routine police services, as provided on a regular basis in the rest of Crossville, will be available to the property upon effective date of annexation.

FIRE

Routine fire protection services, as provided in the rest of Crossville, will be available to the property upon effective date of annexation. The City Fire Department has a Class 3 rating.

WATER

City water lines are presently available to the annexation area at "outside-city" rates. Upon effective date of annexation, the "inside-city" rate would become effective. If in the future, the property were to be subdivided, extension of water lines and hydrants into

the developing subdivision would be the responsibility of the developer, in accordance with the Crossville Municipal Code and the Subdivision regulations of Crossville Planning Commission.

SANITARY SEWER

City sewer collection lines are located on Canary Drive and available upon completion of an approximate 760-foot mainline sewer extension. The property owner will be responsible for material costs, taps and fees at "inside city" rates. If in the future, the property were to be subdivided, extension of sewer collection lines and manholes into a developing subdivision are the responsibility of the developer, in accordance with the Crossville Municipal Code and the Subdivision Regulations of the Crossville Planning Commission. Depending on the capacity needed by the development, a main line extension may be required at the cost of the developer. The cost estimate in the amount of \$6,428.10 must be paid to the City of Crossville within 12 months. If not paid within 12 months, a new cost estimate would be required.

REFUSE COLLECTION

Upon effective date of annexation, the same regular refuse collection services now provided within the municipality will be available for the annexed property.

STREETS

The annexed property fronts on the corner of Walnut Drive and Canary Drive, which is an unimproved right-of-way. Upon annexation, approximately 530-feet of Canary Drive will be annexed in to the City limits at its current condition. This portion of Canary Drive will be accepted as an official City street. Construction of new streets into a developing subdivision is the responsibility of the developer, in accordance with the Crossville Municipal Code and the Subdivision Regulations of the Crossville Planning Commission.

STREET LIGHTING

Installation of street lighting will be evaluated by the City of Crossville and provided to the area according to the City's standard extension polices already in place.

INSPECTION SERVICES

Following effective date of annexation, new structures constructed in the annexation area must comply with International Building, Residential, Existing Building, Property Maintenance, Accessibility, Energy Conservation, Fire, Life Safety, and Plumbing Codes and other codes adopted by the city, as well as obtain building and plumbing permits from the city and be inspected by the city's Building Inspector for compliance with the International Codes. Additions to and/or remodelings of existing structures must also obtain building and plumbing permits and meet International Codes. Other inspection services will be included upon effective date of annexation.

PLANNING AND ZONING

The annexation area is presently within the Crossville Planning Region, so the same regulations pertaining to subdivision of properties will apply following annexation. At this time Crossville has no zoning in effect.

STORMWATER

Following effective date of annexation, new parcels will comply with the City of Crossville's requirements and regulations regarding land disturbance activities. This will include obtaining a Land Disturbance Permit for activities that will disturb more than 4000 square feet and inspections of erosion protection and sediment control best management practices. These newly annexed properties will also be required to follow buffer zone requirements for streams as well as illicit discharge regulations. Existing structures may be required to improve stormwater control as described in the Stormwater Ordinance.

RECREATION

All present and future residents of Crossville are entitled to use any city recreational park.

SCHOOLS

The schools in Crossville and Cumberland County are part of the county-wide system.

ELECTRICITY

Electric services in Crossville are supplied by Volunteer Energy Cooperative.

NATURAL GAS

Natural gas service in Crossville is supplied by Middle Tennessee Gas Utility District.

OFF-PREMISE ADVERTISING SIGNS

There are currently no off-premise advertising signs located on this parcel. Any off-premises advertising signs in the future must be in compliance with all regulations contained in the Crossville Municipal Code.


